ACKNOWLEDGEMENT LETTER

The IRS Enterprising Computing Center (ECC) has received and processed a Registration of Money Services Business (MSB) form, which you have filed. This acknowledgement letter is the only proof of your MSB registration status. You will be sent an acknowledgement letter each time you file an Initial Registration, Renewal, Correction or Re-registration. Even if you need to correct your registration form, it is still a valid registration. To make a correction, please follow the instructions in the following paragraph. Finally, as further proof of registration with IRS, Detroit, please keep the envelope this notice came in with the letter and facsimile.

Verification of Information

Please verify that the information in the computer-generated facsimile is complete and correct, including the Date of Signature and a statement indicating the original signature was present. If corrections are necessary, please make the corrections directly on the facsimile by drawing a line through the incorrect information and writing the correct information next to it. Use the enclosed envelope to return the completed/corrected facsimile to IRS-ECC within 20 days from the date of this letter. Do not send a new Registration form. Make a copy of the corrected facsimile for your business records before mailing. A new, corrected acknowledgement letter and facsimile will be mailed to you within 90 days. Do not send the acknowledgement letter and facsimile back to us unless you have to make corrections. If everything is correct, keep the letter and facsimile in your business records for five years.

Two-year Registration Renewal Requirement

You are required to renew your registration by filing FinCEN Form 107, Registration of Money Services Business, and checking box 1(b) Renewal by December 31 every two years. If you initially registered on any date in one year, you are required to renew your registration by December 31 of the following year. All subsequent renewals are required every 24 months thereafter by December 31. In addition to registering, each MSB is required by law to have an *effective anti-money laundering compliance program* and may have customer identification and record keeping requirements.
